I am writing to see if you might be available on **Tuesday 24 August**, **11.00-12.30 (Bangkok time)**? The purpose of this short and informal meeting is to obtain your experience and views, along with other representatives from the Global Compact for Migration (GCM) Champion Countries in the

region, on how the Regional UN Network can collaborate more effectively with its diverse stakeholders on GCM implementation in Asia and the Pacific.

As you may know, between October 2020 and March this year, we organised five stakeholder consultations leading up to the recently held Asia-Pacific Regional Review of Implementation of the Global Compact for Migration (10-12 March). A wide and diverse group of stakeholders identified gaps, good practices and developed recommendations on the 23 GCM objectives. The Regional Network is drafting an options paper on how it can continue to build and strengthen its collaboration with the growing and increasingly diverse network of stakeholders in the region, and in this regard we would like learn from GCM champion countries on good practices on meaningful engagement and participation of stakeholders.

The questions will centre around 1) expectations and roles of the Regional UN Network by stakeholders, 2) expectations and roles of stakeholders, 3) are stakeholders having a real impact and/or are influencing decisions? 4) how should nomination processes for stakeholder representation and participation in intergovernmental meetings, including the upcoming IMRF and future regional reviews be organised? 5) how to ensure growth and diversity of stakeholders? 6) Lessons learned: Strengths/weaknesses

The meeting will be opened by Dr Nenette Motus, Coordinator, Asia Pacific UN Network on Migration, and Regional Director, IOM Regional Office for Asia and the Pacific. It will follow the Chatham House rule, and recommendations from you will go into the options paper, which is internal to the Regional UN Network on Migration.

REGIONAL CONSULTATION SERIES WITH GCM CHAMPION COUNTRIES IN ASIA AND THE PACIFIC

'Accelerating Safe, Orderly and Regular Migration in the Context of the COVID-19 Pandemic'

BACKGROUND

The first GCM Regional Review for Asia and the Pacific held in March 2021 took stock of the progress made in GCM implementation in the region. To keep the momentum and follow up from the regional review, the Ministry of Foreign Affairs in Thailand propose holding the first in what would be a series of consultations together with the five other GCM Champion Countries in Asia and the Pacific (Bangladesh, Cambodia, Indonesia, Nepal, and the Philippines), in collaboration with the Regional Network for Migration in the Asia-Pacific. Guided by the Global Compact for Migration including its guiding principles, the UN Charter and international law as well as the 2030 Sustainable Development Agenda, this series aims to accelerate and call to action safe, orderly, and regular migration. These consultations also come at a timely moment in light of the COVID-19 pandemic and its adverse socioeconomic impacts and exacerbated vulnerabilities amongst international migrants and their families left behind.

The exchanges will focus on the challenges and opportunities that have emerged in the wake of the COVID-19 pandemic, and on the impacts on migrants and migration processes and systems. This series also provides an opportunity for Champion Countries to discuss key priorities in the region, identify key challenges and develop common solutions that will enable progress towards the implementation of the Global Compact for Migration throughout the Asia-Pacific. In this pursuit, the series will explore and analyze various themes surrounding migration, and their critical intersection with the COVID-19 pandemic. Champion Countries may volunteer to co-host consultations on priority topics that align with the GCM objectives and relevant Sustainable Development Goals (SDGs) and invite expert panelists on the subject to share latest data and knowledge that can contribute to evidence-based policy recommendations. The identification of progress, challenges, opportunities, and recommendations will be captured through an outcome report that will be presented at the International Migrant Day on 18 December 2021 and is envisaged to contribute to the International Migration Review Forum in May 2022.

PROPOSED NON-EXHAUSTIVE LIST OF INDICATIVE PRIORITY AREAS FOR ASIA AND THE PACIFIC

The following is an indicative and non-exhaustive list of potential priority areas that are to be finalized upon consultation with the GCM champion countries in the Asia Pacific Region in accordance with the 23 GCM objectives¹. Each of these priority areas will apply the GCM guiding principles and link with the 2030 agenda for sustainable Development.

Migrants' access to health care and services (GCM Objective 15 and SDG Goals 3, 5, 8 and 16)

- Alternatives to detention including for migrant children (GCM Objective 13 and SDG Goal 16)
- Disaggregated data for evidence-based policy (GCM Objective 1 and SDG Goal 17)
- Return and sustainable reintegration (GCM Objective 21 and SDG Goals 4, 8, 9, and 10)
- Ethical recruitment and decent work (GCM Objective 6 and SDG Goals 8 and 17)
- Addressing vulnerability through pathways for regular migration (GCM Objectives 7 and 5 and SDG Goal 10)

EXPECTED OUTCOMES

- Strengthened regional cooperation and leadership of GCM Champion Countries on areas of regional priority in collaboration with Regional Network for Migration in Asia and Pacific and relevant stakeholders in the region.
- Provide follow up on GCM implementation and review in Asia and the Pacific through a COVID-19 lens.
- Follow the cross-cutting and inter-dependent 10 guiding principles of the GCM².
- Support champion countries in the Asia Pacific region and related stakeholders towards preparation for the International Migration Review Forum (IMRF) in 2022.

An informal summary outcome document will be prepared upon the conclusion of each consultation with a final report to be presented at the International Migrants Day 2021 or subsequently prior to the International Migration Review Forum in May 2022.

CO-CONVENERS

The co-conveners of this multi-stakeholder consultation series will be decided on a voluntary basis and depending on the interest and commitment of the 6 GCM Champion Countries in collaboration with IOM, UNICEF and the Regional Network for Migration in Asia and the Pacific.

PARTICIPANTS

The series would invite representatives at the technical and practitioner level from Champion Countries (Bangkok level and Capital level as required), the UN Network for Migration at the global, regional and national level, stakeholders, including migrants, academia, civil society, trade unions, employers organizations, national human rights institutions, media, thematic experts, and others.

FORMAT

Consultations for the identified priority area could be convened by each of the GCM Champion Countries with the support of the UN Network on Migration at the national, regional and global levels. The consultation series is proposed to be scheduled across each month beginning September (to be confirmed) culminating into key outcomes flowing from the series to be presented at the International Migrants Day 2021 and International Migration Review Forum in May 2022. The outcomes of the series will compliment and synergize follow up to

The guiding principles are people-centered, international cooperation, national sovereignty, rule of law and due process, sustainable development, human rights, gender responsive, child sensitive, whole-of-government approach and whole of society approach.



the GCM regional review process, as well as feed into the International Migration Review Forum to be held in May 2022 in New York.

TIMELINE

The consultation series is envisioned to begin September through to December 2021 and culminating in a final event on the occasion of International Migrants Day (December 18). Alternatively, this may be extended beyond December 2021 if there is scope among GCM champion countries to continue consultations leading up to the International Migration Review Forum (IMRF) that is tentatively scheduled for May 2022.
