### National Committee for Counter Trafficking in Persons - NCCT

- The NCCT is a national mechanism for coordinating and gathering information about the efforts of ministries, institutions, national and international non-government organizations (NGOs), development partners, private sector, and other stakeholders to collaborate together in order to combat human trafficking in a transparent, accountable and highly effective manner, responding to the commitment of the Government to suppress trafficking in persons.
- The composition of the NCCT by the Royal Decree includes 27 members from line ministries.

- Cambodia firmly discourages sex tourism and has zero tolerance for child sex tourism.
- The prosperity of tourism sector in Cambodia accurately reflects the significance of security, safety and political stability factors, all of which determine and ensure sustainable growth in tourism sector.





- Concurring with the development of tourism sector, a number of negative activities have arisen such as: crime, prostitution, human trafficking, child sexual abuse, and drug trafficking.
- Child Safe Tourism Committee of the Ministry of Tourism has been closely working in conjunction with relevant ministries and institutions, private sector and civil society organization to tackle child sex tourism issue and prevent negative impacts of tourism, especially sexual exploitation on children in tourism.



- A lot of perpetrators have been convicted including foreign ones who committed child prostitution.
- Child sex offences have been committed by citizens from different countries and various occupations.
- Business people, teachers, volunteers and professional people have been amongst the offenders.





Two main measures are taken by Child Safe Tourism Committee:

#### **Education Measure**

Educate the public as well as all relevant stakeholders about the safety of children in tourism sector and raise awareness of negative impacts of tourism.

- Regular Training Seminar
- Promotional Materials (stickers, billboards, tent cards etc.)





#### Administrative Measure

Hoteliers and their staffs are educated about child prostitution/ child sex tourism and they are also trained to cooperate in preventing such thing from happening on their premises.

In the case that child prostitution takes place on their premises, their license will be suspended, revoked or terminated and they will be prosecuted according to law.







- Cambodia has set up a strong mechanism to combat human trafficking at national and sub-national levels.
- Law enforcement in Cambodia and strong mechanism protect children from foreign child sex offenders.
- We send a strong message that anyone who abuses children will be prosecuted according to law.
- The effort to eliminate child sex tourism achieves a remarkable result.





- Children's safety and rights reinforcement contributes to Khmer culture upholding and promote the morality of Khmer society, and image purifying of cultural and natural tourism.
