#### ANNUAL REPORT

Of Activities and Achievements against Human Trafficking and Sexual Exploitation in 2016, and Targets in 2017

(Due from 1<sup>st</sup> January to 31<sup>st</sup> December 2016)

#### I. General Overview

The economic environment, politics, and social security in some Western and Asian countries, including the United States of America, change remarkably from one year to another, impacting other nations in terms of the migration of millions of people for living.

Meanwhile, in 2016, the Royal Government of Cambodia put much effort into keeping the growth of the economy to be around 7% per annum and focused on security, protection and social safety throughout the country in order to guarantee political stability; increase living standards of government officials, workers, farmers, and general citizens as well as secure the safety of tourists and investors.

There is only one purpose for the migration of Cambodians, that is to better their living standards in the aspects of economic growth, modernization of technology and materials of each family.

In fact, some people have benefited from migration, especially legal migration, yet there are some people who have kept looking for jobs outside the country by taking risks rather than going through a legal procedure, and they often face high risks of various forms of victimization, such as human trafficking, labor exploitation, sexual exploitation or abuse, organ trafficking, violence, drug abuse and trade, or other crimes which cause more male, female and children victims. This has put an additional burden on families and society to confront health, education, economic and social issues as well as these crimes.

Recently, there has been news of organ and surrogacy trades to illegally take babies outside the country, which suggests a new kind of crime of smuggling or cross boarder infant trafficking. These issues need to be paid more careful attention to, and solutions and immediate prevention by setting up legal frameworks for surrogacy management should be developed as soon as possible.

In the response to this issue, Samdech Akeak Moha Sena Padey Techo Hun Sen, Prime Minister of the Royal Government of Cambodia and Samdech Kralahom Sar Kheng, Deputy Prime Minister, Minister of the Interior and Chairman of the National Committee for Counter Trafficking, have addressed some key points on strengthening local and international alliances and encouraging all levels in the commission to actively implement activities and cooperate with all ministries, related entities, existing authorities, local and international nongovernmental organization partners and encourage anticipation for a successful elimination of human trafficking.

In 2016, activities including cracking down on offenses, victim protection, perpetrator prosecution and prevention that were simultaneously conducted in all target areas by focusing on women and children. National and international cooperation was strengthened and enhanced widely. At the same time, the general department collaborated with NGO Partners to conduct a local job market research to provide choices of work for people, particularly teenagers who need to earn a good living. The mid-term evaluation of Plan of Action (2014-

2016) has been carried out by independent assessors to see the strengths and weaknesses of implementation and for revision of the Action Plan for 2017 and 2018.

The result of action implementation at all levels of the anti-human trafficking commission in 2016 is detailed below in the Annual Report, which was compiled from 6 ministries, 22 entities, 25 provinces and capitals, 24 NGO partners and other important national and international news.

#### II. Results of Anti-Human Trafficking Activities in 2016

The Four Strategic Implementation Areas:

## A. Legal Procedures, Policies and International Cooperation

#### A.1. Legal Procedures and Policy Establishment

For the foundation of anti-human trafficking implementation, the Royal Government, the National Committee for Counter Trafficking, ministries, and related entities have imposed some resolutions, policies and rules as the following:

#### A.1.1. Legislation

Applied Laws and Regulations:

- The Law on Donation Control on Human Cells, Tissues and Organs promulgated by the Royal Krom NS/RBM/0816 dated 9 August 2016;
- The Juvenile Justice Law promulgated by the Royal Krom no. N.SRBK/0716/009 dated 14 July 2016;
- Prakas no. 133/12PR.K on the Promulgation of Guidelines of Application and Legal Procedures on the First Identification of Human Trafficking Victims for Legislative Services prepared by the Ministry of Social Affairs, Veterans and Youth Rehabilitation under the National Committee for Counter Trafficking on 25 December 2015.

Legal Regulations Under Preparation:

- The Draft Law on the Control of Surrogacy (Ministry of Women's Affairs);
- The Draft Law on the Anti-Human Smuggling (Ministry of Justice);
- The Draft MoU on Prisoner Deportation between the Kingdom of Cambodia and the British Government (Ministry of Justice);
- The Draft MoU on Prisoner Deportation between the Kingdom of Cambodia and the Peru Government (Ministry of Justice);
- The Draft Circulation on Domestic Workers' Conditions (Ministry of Labor and Vocational Training);
- The Draft Policy on School Children Protection (Ministry of Education, Youth and Sport).

#### A.1.2. National Policies

- The mid-mandate review of the Plan of Action on Anti-Human Trafficking 2014-2018 to revise the following action plan and for the next implementation in 2017-2018 (supported by Winrock International, and sponsored by the U.S. Agency for International Development);
- (Continue to perform) National Policy on Occupation and Work 2015-2025 of the Royal Government approved by the Council of Ministers during the full meeting on 24 September 2015 with the purposes of (1) Creation of job opportunities and high productivity, (2) Encouragement of skill development and human resources, and (3) Good governance of job markets by applying migration policy that is the key for local job market development as an alternative to and reduction of illegal migration which causes all forms of human trafficking and exploitation.

#### A.1.3. Related Legal Documents

- The National Committee for Counter Trafficking:
  - Amended the Composition of Law Enforcement Working Group through Resolution Letter no. 166/16 SSR dated 1 November 2016 on the Appointment of Law Enforcement Working Group Composition, the National Committee for Counter Trafficking.

#### Ministry of Justice:

- Issued a letter on Judge Guidelines and Prosecutors in provinces and municipalities for the care of human trafficking cases;
- Issued a letter to all capital and provincial Courts of First Instance and Prosecutions for attention of regular data collection on human trafficking cases to be submitted to the Ministry for data summary and timely report to the national working group.

#### • Ministry of Health:

- Issued Prakas no. 679 BrK/SNK on the Management of Blood, Ovum, Marrow and Human Cells dated 24 October 2016 (Module III, Section 2, Article 12: "All surrogacies, one of a set of services to have a baby by assisted reproductive technology is completely prohibited" and Section 3, Article 17: "Prohibition of in vitro fertilization for trading purpose or any purpose of implanting the resulting embryos for legal spouses to be pregnant").
- The Six Provincial Committees for Counter Trafficking:
  - Steung Treng, Prey Veng, Bantey Meanchey, Battambang, Kompot, and Kompong Speu have adjusted the composition of district, commune and Sangkat officials who are in charge of counter human trafficking.
- Ministry of Education, Youth and Sport:
  - Issued Guidelines on the Preparation of National Anti-Human Trafficking Day, 12th December, for all educational institutions nationwide both public and private, to celebrate the National Anti-Human Trafficking Day on the 12th December 2016;
  - Established a framework for mainstreaming and reporting at Provincial Departments by binding branches at District Bureaus and all levels of educational establishments to strengthen the effective prevention and protection of human trafficking in the capital, provinces, cities, districts and Khans.
- Ministry of Social Affairs, Veterans and Youth Rehabilitation:
  - Issued Prakas no. 1759 SAY on the Preparation and Organization of Poipet Transit Center dated 7 July 2016.

# A.2. International Cooperation for Law Enforcement and Policies

#### A.2.1. Agreement and Treaties of Mutual Assistance

  - Treaty with the Social Republic of Vietnam on "Mutual Support on Criminal Sector" (22 December 2016);
  - Treaty with Russia on "Mutual Support on Criminal Sector" (under discussion);

# A.2.2. Memorandums of Understanding

#### **B.** Promotion of Prevention

The effort of prevention is to stop human trafficking and to eliminate all risks for Cambodians who could be victimized by trafficking. Following the policies of the Royal Government of Cambodia in monitoring labor forces inside and outside the country and banning irregular migration to the country, the National Committee for Counter Trafficking has coordinated and encouraged prevention activities. Educational spots, meetings, seminars and all forms of awareness raising activities have been conducted for the public, government officers at both national and sub-national levels, schools, local people, and other communities 30,199 times with 3,740,211 participants — 1,678,230 females. This is more than 2015 which had 3,346,237 participants, a 393,974 increase equivalent to 11.77%.

#### **Prevention Activities in the Education Sector**

The Ministry of Education, Youth and Sport, with its responsibility for preventing human trafficking and sexual exploitation, has played an important role in developing productive human resources and shaping the study goals of students so that they can enter the job market and undertake social leadership work.

Besides the improvement of education quality; increasing student enrollment and access at all levels through clear study curriculums; establishing educational institutions in communities; and providing professional skills, life ethics and life skills for students to become good citizens with enough skills for a quality life, the ministry has developed some programs to prevent children dropouts and dangerous, risky migration. The Ministry has:

- Cooperated with the Ministry of Interior and other organizations to give keychains with the emergency contact of violence, human trafficking, and problem consultation numbers to 300 students.
- Posted some banners on safe migration and human trafficking reduction co-produced by Cambodian Women for Peace and Development and CARE organization in the Cambodian library.
- Posted and shared the hotlines of the Anti-Human Trafficking and Juvenile Protection Department, LSCW, LICADO, CWCC and WEC.
- Provided scholarships for 7,308 students (an increase) (including 4,322 females) in primary and secondary public schools, 2,600 students (an increase) (including 1,560 females) in public high schools, and recalled 1,884 dropout students (including 820 females) to restart their studies (60% female). The income generation program benefitted 549 students (409 females) by providing documents to prevent school dropouts nationwide.
- Had a study program on Ethics, Violence Prevention, and Anti-Discrimination, coorganized with Cambodian Women's Crisis Center, and 84 bicycles and study stationeries were given to the 315 poor students in Phnom Penh and Siem Reap province.
- Cooperated with World Vision organization to hold a workshop on the Prevention of Child Exploitation. Means of transportation, uniforms, trainings, and soft skills in community education centers were provided in order to decrease female migrants; 78 principals (8 females) were trained on how to reduce school dropout rate in designated provinces including Kompong Chnang, Kompong Spue, Kompong Thom, Kompong Cham, Tbong Khmum, and Siem Reap.
- Added Secondary Schools to existing Primary Schools in challenging and remote areas so that all students, especially female students, can access their studies more easily.

#### **B.1.** Awareness Raising

For the educational spots in 2016, all Partners of the National Committee for Counter Trafficking, Provincial Committees for Counter Trafficking, Secretariat, Provincial Departments, related institutions and entities, authority and forces have collaborated with NGO Partners to disseminate information, educational and communication materials to hotel owners and employees of the 25 capital/provinces. Separately, Ministry of Tourism has also raised the awareness of targeted hotel owners and staff of 25 capital/provinces for 524 times with 2,735 participants (2,103 females). There were a total of 3,471 Awareness Raising with 253,094 participants (414 females).

#### **B.2. Public Forums**

- The Head Office of Border Policy publicized the law on Anti-Human Trafficking and Sexual Exploitation in the Communal Safety Program to all people along the Cambodia-Thai border 115 times with 3,133 participants (1,710 females).
- The Ministry of Women's Affairs organized Joint Forums along Cambodia-Vietnam border on Anti-Human Trafficking in Sompov Loun Commune, Koh Thom District, Kandal Province with 300 participants.
- o Contextualized information on anti-human trafficking, safe migration and tricky offenders into awareness raising and public forums of the communal safety policy under local authority operation. This was conducted a total of 27,140 times in the presence of 3,486,870 participants (1,544,933 females) as below:

# B.3. Anti-Human Trafficking Day and Campaign, 12<sup>th</sup> December

- O The National Committee for Counter Trafficking collaborated with NGO Partners (UNACT, USAID through Winrock International, Cambodia ACTs, Terre des Hommes, IJM, IOM, APLE etc) in producing Information, Educational and Communication (IEC) Materials for the Campaign Program of Anti-Human Trafficking Day on 12<sup>th</sup> December 2016 in Phnom Penh. There were 3,000 participants in high ranking positions of Legislatures, the Royal Government, Courts, Authorities, Armed Forces, religious representatives, employers, employees, lecturers, teachers, students and other citizens, presided by Samdech Kralahom Sar Kheng, Deputy Prime Minister, Minister of the Interior and Chairman of the National Committee for Counter Trafficking, honorably representing Samdech Akeak Moha Sena Padey Techo Hun Sen, Prime Minister of Cambodia.
- O The National Committee for Counter Trafficking in 9 provinces (Bantey Meanchey, Battambang, Pursat, Preah Vihear, Siem Reab, Kompong Cham, Takeo, Kandal and Svay Rieng) liaised with NGO Partners in producing IEC Materials for the Campaign of Anti-Human Trafficking Day on 12<sup>th</sup> December 2016 that was held in the presence of 7,606 participants (2,334 females) from provincial, city, village, commune and authority management levels, armed forces, lecturers, teachers, students and local people.

# **B.4.** Production and Distribution of Information, Education and Communication Materials (IEC Materials)

- o The National Committee for Counter Trafficking in Battambang province posted two signs on Prohibition for Under 15-Year-Old Children in Brickmaking in Battambang city and 26 brickmaking places in Sangke district, under the sponsorship of World Vision's Social Movement Against Child Labor project:
  - 'Gather to Stop Under 15-Year-Old Child Labor in Brickmaking Places';
  - 'Be Careful and Strongly Prohibit Under 15-Year-Old Children in Bricking Places'.
- o Oddar Meanchey Provincial Police Commissariat regularly disseminated the Law on Suppression of Human Trafficking and Sexual Exploitation along their target locations in the province.
- O Some NGO partners have also been actively involved in prevention activities by supporting the National Committee for Counter Trafficking and by supporting other local NGO partners in order to take action in villages, communes, Sangkats and districts of provinces which have benefitted tens of thousands of people. These include: USAID through Winrock International, Cambodia ACTs, Terre des Hommes Netherland and Chab Dai, and each has partners taking actions in provinces.

The tools which have been distributed for educational spots, particularly in the campaign of Anti-Human Trafficking Day 12<sup>th</sup> December are:

- T-shirts printed with educational messages;
- Bags printed with contacts of local and international entities and organizations as well as the Embassies at the destination countries;
- Notebooks with the data of the National Committee for Counter Trafficking and brochures on Guidance for Safe Migration;
- Slogan banners;
- Art embedded with educational meanings;
- Reports;
- Short educational videos on CDs and VCDs.

#### **B.5. Media Advertisements**

- o The National Committee for Counter Trafficking has disseminated information through electronic systems such as Email, Twitter, Facebook, Telegram, Messenger and Telephone in order to broadcast all information that is relevant to activities of the committee to the public and international audiences in an effective way and on time.
- o The Ministry of Education, Youth and Sport has created and distributed hotline numbers on social media within schools, Provincial and Municipality Education Departments, and the Ministry as well as within other Ministries so as to inform all about the crackdown on human trafficking.
- The Ministry of Culture and Fine Arts cooperated with movie company directors and movie import and export companies to display educational messages of Impacts of Human Trafficking, Child Labor Exploitation, and Sexual Exploitation during their movies, songs and karaoke displays.
- o Siem Reap Information Department collaboratively asked organizations to be part of "Dialogue Program" and "We Can Do" to spread awareness about issues on Domestic Violence and Irregular Migration and particularly to seek

- assistance from authorities and civil society in the province on 70 discussion topics.
- o Kompot province showed a movie "Where is the Sky" 10 times with 390 participants (194 females).
- O Secretariat of Provincial Committees for Counter Trafficking have broadcasted topics including Anti-Human Trafficking and Sexual Exploitation, Victim Protection, Tricks of Offenders, Safe Migration, Dangers of Labor Migration, Elimination of Child Labor, Child Protection in Tourism, Prevention of Child Sex Abuse, and Prevention of Human Trafficking on the radio for 52 times (8 times in Battambang, 2 times in Kompong Cham, 2 times in Rattanakiri, and 40 times in Siem Reap).

# **B.6. Migration Flow Management**

#### **B.6.1.** Statistics on Control of Cambodian Migration in each Province

According to the statistics of the General Commissariat of National Police whereby the Counter Trafficking and Minor Protection Department and Provincial and Municipality Police Commissariats surveyed the number of nationwide migrants, it is shown that the number of migrants to other countries has gradually increased in 2016 as in the figure below:




# **B.6.2. Private Recruitment Agency Management**


For sending migrant workers to foreign countries, the Ministry of Labor and Vocational Training required each recruitment agent to train and teach foreign languages, primary basic skills, working attitudes, rules of the destination country, living habits, customs


and cultures of the countries where they will migrate to; and to prepare legal documents and workplace letters in that country before sending them to those places.

Statistics in 2016 has shown 60 private firms that recruited, sent and monitored regular migrant workers in five countries through recruitment agencies and the government's Electronic Permit System (EPS) for workers migrating to Korea. The total number of recruited workers increased in 2016 to 30,825 from 25,263 in 2015, an increase of 4,862 persons (12,125 females) equivalent to 18.72%:

# **Data of Migrant Workers Sent Abroad**





Another set of data on 24 border gates from the Identification General Department of the Ministry of Interior stated that agencies sent 59,747 workers to six countries, including Thailand (51,149; 158 females), Malaysia (343; 271 females), South Korea (7,037; 1,604 females), Japan (1,149; 876 females), Singapore (58 females), and Papua New Guinea (11 males).

#### **B.6.3.** The Situation of Migration Flow (Banteay Meanchey province)

Regarding the 2016 report of the Provincial Committee for Counter Trafficking in Banteay Meanchey province, Thailand sent back Cambodian workers in the form of 'deportations' across international gates in total of 1,159 flights/cars with 49,987 workers (16,261 women, 4,264 children, 1,746 girls). Compared to 2015 with 55,626 persons, this is a 5,746 decrease of 10.32%. From quick interviews, it was shown that:

International gates
 Individual migrations
 21,483 persons; Chrok Robeang gate: 28,504
 23,378 persons; followed others: 26,609

o More than a month imprisonment in Thailand 1,784 persons

There were some workers imprisoned from 4 to 15 years for smuggling drugs, deforesting rosewood, servicing transportation of fake products, and holding illegal passports given by a broker whereas those experiencing two-month imprisonment mostly stayed without a residency permit.

The Working Group interviewed 3,038 workers (1,188 females) to determine the identity of suspects who illegally lead them to cross the border, yet there was no information obtained on the brokers' identities.

From the interviews with 571 children (230 girls), it was found that:

- o 343 children followed their parents doing construction work;
- $\circ$  224 children followed their relatives to cassava farms and construction work.

In 2016, there were 125,826 migrants in Bantey Meanchey (53,489 women; 1,185 children), and if compared with 56,474 migrants in 2015, this is a huge increase of 69,352 persons (122.8% increase) as:

o People in province who has returned: 20,032 persons (9,374 women; 329 children).

#### **B.6.4.** Statistics on Migrant Workers Deported by Foreign Authorities

The 2016 report of the Migration Department showed that along international border gates, 111,766 workers (20,863 women; 4,832 children) were received from the authorities of 19 countries to Cambodia (mostly from Thailand: 102,269 persons; 552 persons from Malaysia, 438 persons from South Korea, 105 persons from Vietnam, 46 persons from Indonesia, and 42 persons from America).

# **B.7.** The Provision of Legality to Migrant Workers Abroad

According to the report of the Ministry of Labor and Vocational Training, there are 1,060,000 Cambodians working in Thailand, and there are 360,000 workers without legal documents. The Working Group of the Royal Government of Cambodia has been working the Ministry of Work, Thailand, to issue passports, traveling documents and work permits for them to stay and work legally in Thailand.

The Identification Department has issued 23,697 copies of new traveling documents for Cambodian workers working abroad and printed 234,653 copies normal passports and traveling documents to Thailand from 13<sup>th</sup> October 2014 to 31<sup>st</sup> March 2016, yet there were only 36,478 copies (15.55%) of both documents that were distributed.

#### **B.8. Skills Management Measures**

#### **B.8.1 Prevention through Formal Mechanisms**

Mixed Working Group of Monitoring and Foreign Work Force have inspected enterprises and other institutions in 3,553 places where the number of foreign workers is 27,091 persons (8,552 females) with 81 nationalities. They have fined 1,305 foreign employees without work permits with the fine amounts totaling at 652,500,000 Riels. With this monitoring, most foreign employees have been encouraged to comply with the law in Cambodia by continuously applying for work permits at the Ministry of Labor and Vocational Training.

At the Robeang border, Battambang province, the Standing-Point Border Protection Police Forces No. 817, 819, 823, and 310 have prevented and educated people crossing the border illegally to Thailand. At the same time, the Beong Keng police checkpoint of Banteay Meanchey Police Commissariat in Malai District has joined the Counter Trafficking Office and Border Protection Police Forces No. 815 and 911 to stop and educate the people who are preparing to cross the border illegally or by brokers for work in Thailand.

# Prevention on Human Trafficking for Sexual Exploitation:

In 2016, the General Commissariat of the National Police represented by the Department of Anti-Human Trafficking and Juvenile Protection, and Provincial and Municipality Police Commissariats cooperated with relevant institutions to undertake prevention as below:

- The Provincial Departments of Police Commissariat in Takeo, Kratie, Kompong Chnang, Mondolkiri, Preah Vihear, Steung Treng, Kompot, Kandal and Koh Kong updated statistical data on Agreements of Prohibition of Sexual Exploitation, and disseminated the Law on Suppression of Human Trafficking and Sexual Exploitation to 2,735 persons business owners in 524 places (2,103 females).
- The updated statistical data on Suspicious Human Trafficking and Sexual Exploitation activities in all 25 cities and provinces in 71 places — 5 places of human trafficking and 66 places of sexual exploitation — have been regularly tracked by local authorities.
- Provincial Police Commissariat of Svay Rieng, Siem Reab, Prey Veng, Oddar Meanchey, Kompong Thom, Kompong Chnang, Kompong Speu, Mondolkiri and Takeo have patrolled 283 times on suspicion of sexual exploitation.

The Head Department of Border Police has patrolled 6,602 times in 2016 compared to 4,877 times in 2015 for suspicious irregular border crossings. This is an increase of 1,725 times from 2015, among these 2,961 times controlled cases. Along the Cambodia-Thai border cases were controlled 762 times, Cambodia-Vietnam border 2,126 times, and Cambodia-Lao border 73 times.

# **B.8.2** Prevention of Vulnerability through Marriages between Cambodians and Foreigners

With progressive work from the Ministry of Foreign Affairs and International Cooperation, One Window Working Groups in charge of monitoring and registration of marriage applications between Cambodian and foreigners under the Ministry of Interior have been established consisting of the General Department of Identification, General Commissariat of National Police, General Department of Migration, General Secretary Department, the National Committee for Counter Trafficking, and the General Secretary of the Ministry of Interior in order to control all improper conditions of international marriages for criminal purposes that pose dangers to local people by smuggling or trafficking. In 2016, the number of couple applicants was 1,541. With this monitoring and law compliance, there are yet to be any human trafficking and sexual exploitation cases, except for violence and divorce.

Simultaneously, there are some illegal couples outside the country married through brokers, particularly to China, where victims of sexual exploitation and sexual abuse have been expatriated gradually.

In addition, 224 phone calls have been made to all couples who got married to live in foreign countries for tracking.

# **B.8.3** Interview Results of Workers Deported under Foreign Authorities

According to the report of the General Commissariat of National Police in 2016, the Counter Trafficking and Minor Protection department cooperating with the Ministry of Foreign Affairs and International Cooperation, non-governmental organizations, and embassies collected data on Vulnerable Migrant Workers to develop preventive measures for those migrant workers.

#### Data from the Ministry of Foreign Affairs and International Cooperation

As of the 31<sup>st</sup> December 2016, 815 workers have been rescued and returned to Cambodia (366 persons suspected victims of human trafficking or other crimes) as below:

- o Vietnam 231 persons (marriage to China, 8 persons; and sexual exploitation, 2 persons)
- o Malaysia 272 persons (labor trafficking, 59 persons; and sexual exploitation, 1 person)
- o Thailand 139 persons (110 irregular migrants; fake document stamps, 2 persons; deforesting, 22 persons; and exploited by bosses, 5 persons)
- o Indonesia 78 persons (illegal workers, 76 persons; 1 cheated woman and 1 child)
- o China 64 persons (41 married to Chinese men, 9 illegal migrants, and cheated for education/study 14 persons)
- o Japan 16 persons (9 academic learners and 7 persons sexual exploitation)
- o Singapore 6 persons (Karaoke services, 3 persons and housemaid, 3 persons)

o Lao PDR 2 persons (Marriage and illegal migration)



<u>Notice</u>: According to a report from the Office of Border Defense, General Command of the National Defense Ministry, Cambodian migrant workers who died in Thailand by various accidents were sent by Thai authorities back to Cambodia in 2016 for 173 cases of 181 dead bodies (30 female).

#### C. Strengthening the Criminal Justice System to Respond to Human Trafficking

The results of human trafficking and sexual exploitation crackdowns were received from 18 entities: The Counter Trafficking and Minor Protection department of the Ministry of Interior; the Country Royal Gendarmerie; and Provincial Police Commissariats of Bantey Meanchey, Battambang, Kompong Cham, Kompong Chnang, Kompong Thom, Kandal, Mondolkiri, Phnom Penh, Prey Veng, Pursat, Rattanakiri, Siem Reap, Preah Sihanouk, Kratie, Svay Rieng, and Takeo.

#### **C.1 Law Enforcement**

#### C.1.1 Crackdowns and Securing Victims

The close cooperation between the National Committee for Counter Trafficking and Law Enforcement Bodies — General Commissariat of National Police, Gendarmerie, General Prosecutors, Ministry of Interior, Ministry of Justice and Courts — has enabled antihuman trafficking and criminal punishment to be satisfactory in both qualitative and quantitative ways.

Generally, this success relies on the gradual changes of police forces' attitudes and commitment in investigating, collecting evidence, and being in court for human trafficking cases with the investigation of cases and human trafficking networks.

In 2016, the General Commissariat of National Police with the Provincial and Municipality Prosecutors cracked 92 cases (a decrease of 13 cases compared with 105 in 2015). 113 suspects were sent to courts in 2016 compared to 144 in 2015 (a 31 person decrease), and 46 women and 12 minors were arrested. Among suspects, there were 8 foreigners: 1 Australian, 1 Indian, 1 Pakistani, 1 Vietnamese, 1 Thai, 1 Korean, and 2 Dutch.

298 (a 3 person increase from 2015) victims of human trafficking and sexual exploitation were rescued including 47 under 15-year-old children, 44 aged from 1-15 years,

and 207 aged 18 and above of which were 161 sent to the Social Affairs department, 7 to NGO partners, and 130 to their families.

#### 1. Human Trafficking Cases

In the crackdowns on 27 cases (a 20 case decrease from 2015), there were 39 suspects arrested (21 females) including 3 foreigners, and 111 victims rescued as below:



# $C.1.3 \ Legal \ Solutions \ for \ Complaints \ of \ Migrant \ Workers$

In 2016, the Ministry of Labor and Vocational Training resolved migration complaints against 28 companies with 54 cases, 187 workers (129 females). There were 19 solved cases, zero unsolved, 21 in progress as well as 13 invalid cases.

# **C.2 Justice Affairs**

#### **C.2.1 Prosecution Results**

The data gained from the Justice Working Group of the Ministry of Justice was extracted from the output of prosecution results of Provincial and Municipality Courts on

cases under the counter trafficking and sexual exploitation law and related articles of criminal codes. The court procedures resulted as follows:

#### C.2.2 Actions by Offices of Provincial and Municipality Prosecutions

The actions taken by Offices of Provincial and Municipality Prosecutions, in Battambang and Bantey Meanchey prosecutors over 9 months and in Oddar Meanchey over one year resulted in 116 cases with 87 victims (59 minors); 114 convictions including 17 minors; referral for investigation of 66 cases, no action for 9 cases, direct trial of 1 case and other actions for 40 cases as follows:



# **D. Victim Protection and Support Services**

# **D.1. Intake of Suspected Victims**

The Provincial Committees for Counter Trafficking cooperated with NGO partners to support victims and vulnerable persons by rehabilitating victims at various NGOs in

order to obtain health checks, consultation on choices or legal solutions, emergency aid, residential and food support, and vocational training and life skills. A total of 1,362 victims were then referred to families, which includes 469 women (759 boys and 530 girls), as below:

#### **D.2. Child Protection**

The capital Provincial Committees for Counter Trafficking and capital Provincial Departments of Social Affairs, Veterans and Youth Rehabilitation cooperated with state centers and centers of NGO partners in 2016 in rescuing 652 children (448 girls) children who were trafficked, sexually abused, and labor exploited by providing temporary residential support to manage and take care of those children and reintegrate them back to their families. Separately, at the centers there were intake and care of victims as the following:

# **D.3 Residential Care for Victims**

#### • Preah Sihanouk

Mlop Tapang Organization deployed child protection networks, such as motor taxi drivers and tuk tuks totaling to 120 persons in 24 guest houses and hotels, 59 seashore sellers, 57 community officers and 2 travel agents.

#### • Kandal Province

The Department of Social Affairs assigned a focal point official for alternative care for children and monitored the implementation of the Minimum Standard Policy on alternative care at nine orphanages — Boeng Khchar, Klara house, Child House of Cambodia-France-Hungary Friendship, Happy Land, Swiss Child International, Sre Ombil, Arunras Child Village, Emanuel, Good News, and Chiloodia Hope — where 580 children were being sheltered (255 girls).

#### • Rattanakiri Province

The Department of Social Affairs has overseen the implementation of minimum standards for maintenance of children in care centers where there are 152 children (63 girls).

#### • Pursat Province

There are two vocational training centers and one school of vocational training where all victims, vulnerable people and ordinary people can access trainings.

Six orphan centers including a state-owned center and five organizations, and 9 alternative care centers for orphans in the community are as follows:

#### **D.4 Rescue Services for Victims**

The Transit Center has cooperated with the Cambodian Women's Crisis Center to provide clothes and daily usage equipment for 97 victims and vulnerable persons. Each of them was given 2 pairs of trousers, 2 t-shirts, 1 towel, 2 pairs of underwear, 1 pair of flip flops, 1 bottle of shampoo, 1 toothpaste, 1 toothbrush, 1 soap, 1 package of soap powder, and a luggage bag.

#### **D.5 Victim Reintegration**

The Department of Social Affairs, Veterans and Youth Rehabilitation cooperated with other NGO Partners to return all returned victims to the community. This was a total of 58 persons (54 women & 4 girls), 18 from Siem Reap, 16 from Kandal and 24 from Destiny Rescue organization.

The Phnom Penh municipality Department of Social Affairs, Veterans and Youth Rehabilitation received 1,904 homeless individuals (non-voluntary submission) (855 females) to its Transit Center for short vocational training, and 1,603 persons (710 females) for returning to their communities.

#### III. Capacity Building

#### A. Inside Country

#### A.1 Trainings

In 2016, General Secretariat of the National Committee for Counter Trafficking, the Ministry of Women's Affairs, the Ministry of Tourism and the General Commissariat of the National Police collaborated with NGO partners to conduct trainings to strengthen the qualifications of teachers, officers, members of the National Committee, and officers of the general department in 29 courses with 1,126 participants (497 females) on the topics of Legal Skills and Crackdowns on Human Trafficking as well as Victim Protection.

Moreover, the General Secretariat of the National Committee for Counter Trafficking as well as 13 Provincial and Municipality Departments (Kompot, Battambang, Kompong Speu, Svay Rieng, Kandal, Kompong Chnang, Kompong Cham, Kratie, Preah Sihanouk, Prey Veng, Rattanakiri, Pursat and Takeo) closely cooperated with experts from ministries, departments, entities and stakeholders to provide trainings for participants of commune

councils, grass root level officials, provincial secretary officers, focal points, pre-departure trainers, law enforcement officers, teachers, staff of organizations and tourist operators at hotels as well as local people. A total of 75 courses were provided with a total of 3,635 participants (1,786 females).

The total number of trainings in 2016 was 104 with 4,761 participants; 2,283 females (Annex 1).

#### A.2 Seminars/Workshop

In 2016, there were some important seminars led by Samdech Kralahom Sar Kheng, Deputy Prime Minister, Minister of the Interior and Chairman of the National Committee for Counter Trafficking (NCCT):

- (1) Seminar on "The Control of Irregular Flow of Cross Border Migrant Workers" held at Bantey Meanchey Provincial Hall and participated in by ministry leaders, the members of NCCT, provincial border leaders of 7 provinces, borderline standing-point leaders, border district and commune chief officers and relevant NGO Partners, joined by a total of 193 participants (23 females). The seven relevant provinces are: Bantey Meanchey, Pailin, Preah Vihear, Oddar Meanchey, Koh Kong, Battambang, and Pursat including the national level management team.
- (2) Consultation Workshop on "The Encouragement of Law Enforcement for Human-Trafficking Victims' Justice" held in Phnom Penh presided over by the management of the Ministry of Interior; the Ministry of Social Affairs, Veterans and Youth Rehabilitation; the Ministry of Labor and Vocational Training; General Prosecutors of the Supreme Court; the General of the General Prosecution Department, Lok Chumteav Chou Bun Eng Secretary of State from the Ministry of Interior, General Secretariat of NCCT, Judges, Provincial and Municipality Prosecutors, high-ranking officials from other ministries and institutions, legal entities at both sub-national and national levels, and NGO Partners in total of 159 persons (47 females).

Besides the General Secretariat of NCCT, the Secretariats of Provincial Committee for Counter Trafficking have conducted workshops on some significant topics which prioritized the work of anti-human trafficking. They conducted 38 trainings with 2,869 participants (1,098 females) as following:

- Ministry of Labor and Vocational Training: Workshop on "System of Worker Recruitment to Saudi Arabia."
- Ministry of Education, Youth and Sport: 11 Workshops with 1,582 participants (631 females):
  - Workshops 4 times in Kompot, Oddar Meanchey, Rattanakiri and Takeo on the topic of "Law Conditions of Anti-Human Trafficking" participated by 326 persons (57 females);
  - Joint training workshop with NCCT on "The Efficiency of Building Human Trafficking Prevention and Protection, and Promoting Good Environment and Sanity at Educational Institutions" held at 7 provincial and municipality pedagogical centers, in Takeo, Kandal, Prey Veng, Battambang, Kompong Chnang, Kompong Cham, and Phnom Penh capitals. There were 506 (192 females) education officers and teachers, 750 pedagogic students (382 females), and other 1,256 participants (574 females).
- - Ministry of Tourism held 4 training workshops on "Child Safety in Tourism for Private Tourism" in 4 provinces: Kompot (62 persons, 26 females), Thbong Khmum (57 persons, 24 females), Kompong Cham (71 persons, 32 females) and Bantey Meanchey (76 persons, 35 females), totaling 266 persons (117 females).

- General Commissariat of the National Police represented by the Department of Anti-Human Trafficking and Juvenile Protection held a workshop on "Relevant Activities of Child Labor" with 22 participants (16 females).
- **Svay Rieng Province**, a workshop on "Actions Against Child Labor" was held at the at higher education level with 21 participants (8 females).
- **Takeo Province**, there were seven workshops with 365 participants (160 females):
  - Two Communal Safety Workshops on "Preventive and Protective Measures Against Human Trafficking" with 105 participants (47 females) supported by VCAO:
  - Five Communal Safety Workshops on "Preventive and Protective Measures against Human Trafficking and Safe Migration" supported by VCAO with 260 participants (113 females).
- **Battambang Province**, eight workshops with 332 participants (105 females):
  - Joint workshop with World Vision on "The Reflection on Results of Project Implementation and Plan Development of Child Protection and Labor Elimination" with a total of 48 participants;
  - The Provincial Department of Labor and Vocational Training conducted 8 workshops on "The Control of Work Transmission to Foreign Countries through Private Recruitment Agencies" under the Sub-Decree no. 190 of the Royal Government of Cambodia and additional Prakas of the Ministry of Labor and Vocational Training in 5 districts (Sangke, Banon, Thmor Kol, Ek Phnom and Battambang city) with 201 participants (77 females). One workshop at Mong Russey district under sponsorship of World Vision and ILO-Triangle added extra content related to worst forms of child labor with 41 participants (12 females).
  - Workshop on "The National Plan of Action on Child Labor Reduction and Elimination of Worst Forms of Child Labor (2016-2017)" at Khemara Battambang Hotel, sponsored by World Vision with 42 participants (16 females).

#### **A.3 Coordination Meetings**

There were 576 coordination meetings by internal institutions, inter-institutions and international agents in 2016. These were carried out by the National Committee for Counter Trafficking (NCCT), (196); Ministry of Education, Youth and Sport, (7); Ministry of Social Affairs, Veterans and Youth Rehabilitation (38); Ministry of Labor and Vocational Training (3); Ministry of Women's Affairs (30); Ministry of Justice (13); Department of Anti-Human Trafficking and Juvenile Protection (3); and Provincial and Municipality Secretariats (286) (Annex 2).

## **B.** Outside the Country

#### **B.1 Meeting Participation**

To promote international cooperation, the National Committee for Counter Trafficking and some other ministries (Ministry of Women's Affairs/COMMIT, Ministry of Labor and Vocational Training, Ministry of Social Affairs, Veterans and Youth Rehabilitation, Ministry of Education, Youth and Sport, and the General Commissariat of National Police) as well as 6 Provincial Secretariats (Preah Vihear, Svay Rieng, Pailin, Kandal, Kompong Thom, and Takeo) sent their expert officers to join meeting in regional countries so that they are able to promote cooperation and exchange experiences in antihuman trafficking work.   - On "Investigation Skills for Investigators on Human Smuggling", 1 officer, Indonesia.

# IV. Monitoring and Evaluation

Monitoring has been conducted through:

- Monthly, quarterly, semi-annual and annual reports of provincial levels and Working Groups;
- Monitoring direct practice conducted by officials from the General Secretariat
  of NCCT in some provinces related to the achievements of Provincial
  Secretariats (Siem Reap, Kandal, Banteay Meanchey and Svay Rieng);
- O Monitoring implementation of justice police officials, from the General Commissariat of National Police during work performance;

o The Mid-Mandate Evaluation of the National Plan of Action (2014-2019) supported by Winrock International.

In 2016, a research on Job Opportunity Markets was conducted under the support and cooperation of Cambodia ACTs, whose research result has been launched in a Seminar in order to collect more inputs. The purpose of this research is to create local employment opportunities where workers can work rather than taking hazardous risks to find jobs outside the country.

#### V. Conclusion and Evaluation

#### A. Strengths

Based on the Report of Crackdowns from authorities both police and gendarmerie, there was a 13 case decrease in 2015 compared to 2014 and 20 case decrease in 2016 compared to 2015, while sexual exploitation cases increased by 7 in 2016. Overall, the results of anti-human trafficking actions this year has shown the careful attention and commitment of the Royal Government of Cambodia and all levels of administration, multi-police forces and other stakeholders who have closely and well cooperated to slow the pace of migration, school dropouts, and job employment risks outside country through brokers. Information access and awareness of the advantages and disadvantages of migration, tricks of brokers and impacts of human trafficking have been spread to vulnerable areas, especially to teenagers inside and outside schools, and communities where there are migrants. Victims have been well paid attention to by being provided with life skills education, skills and jobs as well as the good care from institutions and NGO partners. Law enforcement has been strengthened and inspected for careful legal procedure enforcement.

The results achieved depended on the following:

- 1. National Policy Reform in all Sectors of the Royal Government has brought more employment opportunities to millions of Cambodian people and more earnings for good living standards.
- 2. Policies on Village and Communal Security is still the most mobilized element to urge all local forces to come together for safety and security of people. They are involved in crack downs, preventing vulnerability, and reinforcing and rescuing victims more effectively.
- 3. National Policy on Work and Occupations (2015-2025) and Policy of Labor Migration for Cambodia (December 2014) as well as legal norms related to the Migration Flow Management to foreign countries through private recruitment agencies have increased more chances of work inside the country and legal work outside the country, and reduced risks to migrant workers.
- 4. Policy of Migration Flow Management is also a preventive part of illegal migrant flow to Cambodia for employment which could be a push factor for Cambodian workers to migrate abroad.
- 5. The royal government has also committed to finding any cooperative work with other developed countries to send thousands of Cambodian workers for legal foreign employment.
- 6. The Royal Government of Cambodia has also provided legality for migrant workers who illegally migrated, are migrating and staying for work in other countries, to gain legal rights, job safety at their workplace and gain full work benefits for tens of thousands of workers.
- 7. The Royal Government of Cambodia has continued to be highly committed against trafficking in persons by protecting the legal rights and benefits of people and punishing criminals.

- 8. The Laws on Suppression of Human Trafficking and Sexual Exploitation, Criminal Procedure Code, and Penal Code have been carefully implemented. Also, a number of other legal regulations were created to supplement and coordinate the effective implementation of the laws.
- 9. Signed mutual Agreements on Criminal Procedures with five countries (Vietnam, Lao, Russia, England and Peru), Agreements on Expatriation with seven countries (Thailand, Lao, Vietnam, China, Korea, France and Russia) and Prisoner Extradition Agreements with seven countries (Thailand, Vietnam, Australia, India, Russia, England and Peru).
- 10. Working procedures and cooperative relations with ministries and other entities have been tightened and expanded widely to reach a common goal.
- 11. There have been broad strategies for preventing, cracking down, punishing criminals and protecting victims by identifying the signs of hidden victims and providing rehabilitation, reintegration and repatriation.
- 12. The General Secretariat of NCCT has played important roles in connecting and coordinating with relevant institutions and in promoting law enforcement, norms and duties of ministries, institutions, entities and partners in the framework of the National Committee for Counter Trafficking at both national and subnational levels to be more active and effective.
- 13. The skills, attitudes and commitment of law enforcers have improved a lot in applying investigative techniques and evidence collection, and inside the court system in human trafficking cases by focusing on the size and network of each trafficking case.
- 14. Parties in multi-sector forces at both national and subnational levels are coming together in power, resources and means to react against human trafficking on time and in more effective ways.

#### B. Residual Points and Challenges

The simultaneous efforts and determination of the Royal Government of Cambodia and of law enforcement officials in all levels of the NCCT framework above have had positive results, but there are some residual points and challenges to be paid attention to, amended and solved as follows:

- 1. The pace of migrant flow or migration is still in progress, but the management is not sufficient yet and data collection of in/out workers is not clear and precisely classified of the number of workers who migrated.
- 2. The situational of management and data systems of Cambodian workers outside the country is not strong yet.
- 3. Attempts to illegally migrate to other countries for jobs and living standards are a challenge for law enforcement and carry a high risk of exploitation. This is despite the illegal migration of workers to other countries being prohibited and resulting in arrest by the authorities and being expatriated, imprisoned or fined or tortured.
- 4. Some Cambodian workers' identities have been falsified to be sent to illegal fishing boats and are trafficked to other countries. At the same time, there are some signs of new crimes to be concerned with as well.
- 5. The number of in-custody-persons (victims) in foreign countries is at large and those in-custody-persons were continuously repatriated to Cambodia with other victims whose number gradually increases; and we lack; and we lack state-owned rehabilitation centers for those trafficking victims.
- 6. Despite widespread information about the risks, some people still trust in brokers in order to illegally migrate for employment, marriage, surrogacy, etc. Recently,

- there are a growing number of entertainment establishments with hidden prostitution that is another source of human trafficking, sexual exploitation and other crimes.
- 7. Some ministries, entities, and institutions have yet to value the significance of cooperation, and have also yet to fill the gaps of demand for anti-human trafficking and victim protection services.
- 8. In provinces/capital, the changed compositions of Secretariat Working Groups have not been well assigned and limited the implementation and follow up of work progress.
- 9. The absence of restrictions on the actions of recruitment agencies or employers who disobey the law and who put migrant workers in danger. The Government does not have any clear solution and this impacts workers and their families as a result.
- 10. Justice Working Group has an important part to facilitate the legal framework and cooperation whereby we see some gaps in criminal justice, cooperation, punishment, and trafficking victim rescuing outside the country that should be taken action on as a priority.
- 11. Some relevant legal standards have not been so improved that some crimes can happen in loopholes.

#### VI. Targets in 2017

To close the gaps and strengthen the efficiency of the four strategic implementation areas: (1) Improvement of Law Enforcement, Policies and Cooperation; (2) Promotion of Protection and Prevention; (3) Enhancement of Criminal Justice; and (4) Promotion of Victim Protection against Human Trafficking in all forms towards Cambodian people of the Kingdom of Cambodia, such as smuggling and labor exploitation, sexual exploitation, organ trade, baby and child cross-border smuggling and labor abuse in fishery industries, and to tighten working framework procedures more effectively, the National Committee for Counter Trafficking has set key important targets as below:

- 1. Join together to push a strong implementation of:
  - a. The Royal Government Guideline no. 001 KKN dated 25<sup>th</sup> July 2013 on Labor Migration Flow Management;
  - b. High Four Recommendations of Samdech Akeak Moha Sena Padey Techo Hun Sen, the Prime Minister of Cambodia, stated at the National Day Against Human Trafficking on 12<sup>th</sup> December 2015 at Koh Pich Convention and Exhibition Hall in Phnom Penh capital; and
  - c. The Six Counter-Measures of Samdach Kralahom Sar Kheng, Deputy Prime Minister, Minister of the Interior, and Chairman of the National Committee for Counter Trafficking.
- Together follow up on the Results and Effectiveness of all Implementation of the Existing Bilateral and Multilateral Agreements, and support the implementation of the ASEAN Convention Against Trafficking in Persons signed by Samdech Akeak Moha Sena Padey Techo Hun Sen, the Prime Minister of Cambodia on 21<sup>st</sup> November 2015.
- 3. Disseminate 2016 Reports, 2017 Targets, and Evaluation Results of the Implementation of the National Plan of Action against Human Trafficking and the Enhancement of further Actions in 2017-2018.
- 4. All levels of the NCCT, the Municipality and Provincial Committees for Counter Trafficking tighten coordination and expand wider cooperation with all sectors

including the Royal Government, national and international NGO Partners, Civil Society, and Private Sector to create activities to implement the four planned strategies in the National Plan, the Work Plan of the six Working Groups, and 25 Provincial Plans. Together share responsibilities and force deployment to reach the common goal which is Working Towards Human Trafficking Elimination in all Forms.

- 5. Prevention Working Group and all institutions continue to spread all forms of education and resources to promote awareness of human trafficking, sexual exploitation, labor exploitation, connections between migration and human trafficking, and other related offenses more widely to all aimed people, especially teenagers both inside and outside schools as well as vulnerable people.
- 6. International Cooperation Working Group, institutional ministries, related bodies and General Secretariat of the NCCT:
  - a. Have a Bilateral Meeting with the Ministry of Public Health of China to establish Agreement of Implementation of the Plans;
  - b. Prepare to sign Bilateral Agreement between Cambodia and India;
  - c. Encourage discussions with other related countries on Cooperation Strengthening;
  - d. Prepare to consult with sending and receiving counties (Thailand, Malaysia, etc.) in order to build up cooperation, responsibility sharing, and worker interest protection, especially workers in fishery industries, housemaid workers, and employers between sending and receiving countries in the way of equity;
  - e. Encourage the enforcement of legal policies and standards following each target institution and ministry to achieve the goals of the Royal Government against Human Trafficking.

#### 7. Victim Protection Working Group:

- a. Review the results of victim services provision in rehabilitation centers, NGO Partners, and communities;
- b. Continue building state-owned Rehabilitation Centers for Trafficking Victims who are repatriated from abroad;
- c. Continue to provide trainings on Victim Identification to officials of ministries, institutions, local NGO Partners, and Embassies based in Cambodia and targeted countries and follow up on enforcement.

#### 8. Law Enforcement Working Group:

- a. Push and promote the investigation and offender detection of those involved in human trafficking;
- b. Continue strengthening the application and strict counter-measures for timely human trafficking crackdowns and victim rescuing;
- c. Detect all targeted suspects and take actions;
- d. Cooperate with courts in providing evidence against suspects to bring justice to the victims.

#### 9. Justice Affairs Working Group:

- a. Encourage the request of approval on Anti-Human Smuggling Law;
- b. Encourage the preparation of Law on Surrogacy;
- c. Encourage the punishment of human trafficking criminals at Provincial and Municipal Courts of First Instance;
- d. Encourage data collection on Criminal Punishment and Study on the Strengthening of Law Enforcement for Justice of Trafficking victims;

- e. Encourage the preparation, signing and application of the Legal Mutual Assistance Agreements in Criminal Sectors of Extraditions and Prisoner Exchange;
- f. Reinforce penal justice system; mainly tighten mutual assistance cooperation in Criminal Sectors of related countries.
- 10. Migration Working Group and the General Secretariat of NCCT:
  - a. Study the Research results on Employment Opportunities as Alternatives for Cambodian Workers both inside and outside the Country, find out encouraging factors, and plans to prevent risky migration;
  - b. Encourage monitoring of recruitment agencies to properly comply with Royal Government policies;
  - c. Continue to plan for "Irregular Boundary Migration Flow Management" following the leading comments of Samdech Kralahom Sar Kheng, Deputy Prime Minister, Minister of the Interior, and Chairman of the NCCT.
- 11. General Secretariats and all levels of NCCT continue to organize training activities, developing skills for all related officials, and tighten the management and working procedures of Working Groups and Provincial/Capital Secretariats.
- 12. Together support and reinforce the implementation of Village and Communal Safety Policies of the Royal Government.

#### Annex 3

According to the Annual Report of the General Commissariat of National Police, 2,254 illegal migrant workers were interviewed by the local authorities at the checkpoints who were arrested for more than one month by Thai authorities and extradited to Cambodia. All migrants have been educated and sent back home.

The total number of migrant workers is 54,785 (17,775 females), 209 persons (134 females) extradited through the Cambodia-Vietnam border gates and 54,576 persons (17,634 females) through Cambodia-Thai border gates.


